ORDER

Clark Energy Cooperative, Inc. (Clark Energy) is hereby notified that it has been named as a Defendant in a formal complaint filed on June 11, 2021, a copy of which is attached to this Order.

The Commission directs the parties to the March 16, 2020 and March 24, 2020 Orders in Case No. 2020-00085¹ regarding the filing of physical documents with the Commission. In the March 16, 2020 Order, the Commission stated that if a nonelectronic case is not converted to an electronic case, the Commission will grant a deviation from the filing requirements 807 KAR 5:001, Section 7(1), insofar that a filer may file one original document with no copies, or send an electronic mail message with an electronic copy of the document to the Commission and to parties to the matter. The Commission expects that original documents will be filed with the Commission within 30 days of the

lifting of the current state of emergency. Any electronic email filed in this manner should be sent to PSCED@ky.gov, and each message should include the case number in the subject line of the message and a read receipt to ensure the Commission received the message and documents.² A party filing a paper containing personal information shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

Pursuant to 807 KAR 5:001, Section 20, Clark Energy is HEREBY ORDERED to:

- 1. Satisfy the matters complained of or file a written answer to the complaint within ten days from the date of entry of this Order.
- 2. If Clark Energy files a written answer, the answer shall include an image from Clark Energy's mapping software indicating where Michael Bishop's streetlight was located, the pole number of Mr. Bishop's streetlight, and the location and pole number of streetlights on properties adjoining Mr. Bishop's residence.
- A copy of this Order shall be mailed to Mr. Bishop, by U.S. mail, at 128
 Spring Meadows Drive, Jeffersonville, Kentucky 40337.

ON APRIL 6TH MY ELECTRIC WAS SHUT OFF DUE TO NONPAYMENT. I THEN PROCEEDED TO THE MAIN OFFICE IN WINCHESTER AND MADE THE REQUIRED INSTALLMENT TO HAVE IT REINSTATED. WHILE THERE I ASKED ABOUT A UTILITY LIGHT THAT I NOTICED ON THE WAY THERE THAT WAS ON MY BILL. I HAD CALLED IN 2016 AND HAD THE LIGHT AT THE END OF THE CUL-DE-SAC TURNED OFF AS I WAS GETTING NO BENEFIT FROM IT AND AT THE TIME I WAS THE LAST HOUSEON THE ROAD. IT WAS TURNED OFF IN 2016. I THOUGHT NO MORE OF ITAND AS MY BILLS WEREON AUTOPAY I NEVER REALLY EVEN THOUGHT TO LOOK SINCE THE LIGHT HAD ACTUALLY BEEN TURNED OFF. THERE IS ANOTHER LIGHT BETWEEN MY HOUSE AND THE PRECEEDING HOUSE BUT ASHOW THE NEIGHBOR (NOW DECEASED) HAD CALLED CLARK RECC OUT LAST YEAR TO WORK ON THE LIGHT AND TURN IT TOWARDS HER DRIVEWAY I NATURALLY ASSUMED SHE HAD BEEN PAYING FOR IT. WITH THE LIGHT THAT HAD BEEN TURNDED OFF BEING OFF AND THE NEIGHBOR PAYING FOR THE LIGHT SHE HAD CLARK RECC WORK ON I SAW NO REASON I SHOULD HAVE A \$10 (APPROX) FEE ADDED TO MY BILL EVERY MONTH. WHEN ASKED ABOUT THE CHARGE I WAS TOLD THEY DID NOT KNOW WHICH LIGHT I HAD BEEN PAYING FOR BUT AS I EXPLAINED THAT THE ONE WAS OFF AND THE OTHER WAS PAID FOR BY THE NEIGHBOR I SHOULD BE REIMBURSED FOR THE ERRONEOUSCHARGES OVER THE LAST 5 YEARS. I WAS TOLD EMPHATICALLY "NO" YET WAS STILL NOT TOLD WHICH I HAD BEEN PAYING FOR, THE LIGHT THAT HAD BEEN TURNED OFF OR THE LIGHT THE NEIGHBOR HAD THEM COME WORK ON FOR HER. AFTER SOME TIME I WAS GIVEN A PIECE OF PAPERWITH A TAG NUMBER ON IT THAT A LADY HAD RETRIEVED FROM THEIR RECORDS AND TOLD THAT THIS WOULD BE THE ONE I HAD BEEN PAYING FOR. THAT AMOUNT THAT HAD BEEN PAID OVER OVER THE YEARS WOULD HAVE PAID IN FULL ALL LATE CHARGES I HAD INCURRED WITH CLARK RECC LEAVING ONLY MY NORMAL MONTHLY BILL TO PAY. I WAS TOLD THAT I WOULD NOT BE REIMBURSED THAT MONEY FOR ANY REASON. BEING AS I STILL OWED FOR A MONTH OF SERVICE THERE WAS A NEED IN MAKOING SOME SORT OF ARRANGEMENT THAT WOULD ALLOW MY ELECTRICITYTO REMAIN ON WHILE I CAUGHT UP THE MONTHLY FEE AND PAID EXTRA ON THRE LATE AMOUNT IOWED. THIS ENTIRE DISCUSSION HAD BEEN TAKING PLACE WITH MYSELF AND AT LEAST 3 CLARKRECC EMPLOYEES. MR. BREWER, THE I ASSUME VICE PRESIDENT(?), AND ONE OF THE BILLING LADIES IN THE OFFICE. BOTH MR. BREWER AND MYSELF WERE JUST A BIT OUT OF SORTS AS HEWOULD NOT LISTEBN TO ME AND I WOULD NOT LISTEN TO HIM ON THE MATTER OF THE LIGHT. IASKED ABOUT AN ARRANGMENT THOAT COULD BE MADE REGARDING THE AMMOUNT STILL OWED AND IWAS GIVEN A PIECE OF PAPER STATING I HAD TO PAY AN EXTRA \$120 A MONTH. I, LIVING ONDIDSABILITY KNEW I COULD NOT AFFORD THAT AMOUNT EVERY MONTH AND WOULD CERTAINLY BE SETTING MYSELF UP FOR MORE CHARGES BEING ACCRUED ALONG WITH RECONNECT FEES AND SUCHSTATED I COULD NOT AFFORD THAT AMOUNT AND ASKED WHAT WE COULD DO TO MEET IN THE MIDDLE OR MAKE SOME ARRANGEMENT I COULD AFFORD. I WAS TOLD THAT THERE WOULD BE NO OTHER AMOUNT DISCUSSED AND THAT I WOULD HAVE TO PAT THAT AMOUNT. I STATED I WOULD PAY THEM AN EXTRA \$5 A MONTH IF THEY WOULD NOT BUDGE OFF OF THE \$120 A MONTH EXTRA SO THAT I WAS IN GHOOD FAITH PAYING EXTRA AND CATCHING THAT PAYMENT UP. IF I HAD EXTRA AT SOME TIME IN THE FUTURE I COULD HAVE CERTQAINLY PUT THAT TOWARDS ANY LATE CHARGE I MAY STILL HAVE HAD. MR. BREWER WOULD NOT BUDGE OFF OF THE \$120 AND IT WAS 30F THEM AGAINST ONE OF ME AND SEEING AS HOW MR. BREWER WAS STARTING TO TURN RED ANDYELL AT ME THROUGH THE SAFETY PARTITION I FIGURED IT BEST I LEAVE AND I ASSUME HE HAD SOMEONE CALL THE POLICE AND HE STARTED TELLING ME TO LEAVE. AS I WAS LEAVING I POINTED AT THEIR SECURITY CAMERA AND TOLD HIM TO SAVE THE FOOTAGE AS I WAS NOT AGREEING TO ANY \$120 MONTH EXTRA AND HE WOULD NEED TO HAVE THAT FOOTAGE. ON MAY THE7TH I CALLED THE OFFICE AND INFORMED THE LADY

WHPO ANSWERED THE PHONE THAT I WAS ABOUT TO PAY THE BILL THAT WAS LATE AND I WAS ADDING THE \$5 TO THE AMOUNT JUST AS IHAD STATED REPEATEDLY THE MONTH PRIOR. ON MAY THRE 19TH I WOKE UP AND MY ELECTRIC WAS OFF. IMMEDIATELY CALLED CLARK RECC AND WAS TOLD IT WAS DUE TO FAILING TO KEEP THE ARRANGMENT WE HAD MADE. I STATED WE HAD MADE NO ARRANGMENT AND POINTED TO THE

FACT THAT I HAD STILL DONE WHAT I SAID I WOULD DO AND PAID THE EXTRA \$5. I IMMEDIATELY CALLED BACK TO THE P.S.C. AND TOLD THEM WHAT HAD HAPPENED AND THE LADYCALLED CLARK RECC. THAT AFTERNOON STILL OWITH NO ELECTRCITY I CALLED BACK TO THE P.S.C AND WAS TOLD THAT THE REASON GIVEN WAS THAT I HAD FAILED TO UPHOLD THE PAYMENT ARRANGEMENT . I TOLD THE LADY THAT THERE WAS NO ARRANGMENT MADE BUT THAT I HAD KEPT MY WORD TO THE VERY LETTER OF THRE WORD AND PAIFD WHAT I COULD AFFORD EXTRAS JUST 12DAYS PRIOR. I HAD RECIEVED NO DISCONNECT NOTICE AND THE PAYMRENT ON THE 7TH HAD BEENACCEPTED AND CLEARED THE BANK BY THEN. I FEEL MR. BREWER IS DOING THIS OUT OF SPITEFOR VINDICTIVE REASONS AND THAT HE SHOULD NOT BE ALLOWED TO GET AWAY WITH THAT SORTOF UNACCEPTABLE BEHAVIOR JUST BECAUSE HE IS IN A POSITION OF "POWER" AND CAN REIGHNDOMINION OVER CUSTOMERS WHO HE DOES NOT LIKE OR AGREE WITH SIMPLY BECAUSE HE WAS WRONG. IN THE MONTH BETWEEN APRIL THE 6TH AND MAY THE 19TH, MR. BREWER HAD LINEMAN COME OUT AND CHECK THE LIGHT THAT WAS TURNED OFF WHEN I HAD CALLED IN 2016. I SPOKE WITH THRE LINEMAN THAT DAY AND WAS TOLD THAT HE DID NOT HAVE ANY PART IN ANY OF IT AND WAS JUST TOLD TO COME TURN OFF THE LIGHT BU T THAT WHEN HE CHECKED THE LIGHT ITWAS ALREADY UNSCREWED. AS FAR AS I KNOW AND AM AWARE OF ONLY THEY WOULD HAVE THE ABILITY OR THE REASON TO UNSCREW THE BULB AS THERE HAS BEEN NO OTHER CONTRACTOR'S ONTHE POLE SINCE IT WAS TURNED OFF IN 2016. HE ALSO HAD THE POLE BETWEEN MY HOUSE ANDTHE PROCEEDING HOUSE (DECEASED NEIGHBOR) CHANGED OUT FOR SOME UNKNOWN REASON. I USEDTO INSPECT THE VERY UTILITY POLES THAT CLARK RECC UTILIZES AS A JOB I HAD SEVERAL YEARS AGO AND I CAN ASSURE YOU THAT THERE WAS NOTHING WRONG WITH THE STRUCTURAL INTEGRITY OF THAT POLE. THE LINEMAN CLAIMED THEY WERE TOLD TO PUT A TALLER (10') POLE IN TO CLEAR THE LIMBS OF THE TREES. A 10' CHANGE IN ALTITUDE MAKES NO DIFFERENCE IN THE INTERFERENCE OF ANY LIMBS IN THE LINES AS THE LINES ARE ALREADY OUTSIDE THE VERTICAL REACHES OF ANY TREES. THE ONLY WAY THAT EXCUSE WOULD HAVE BEENAT A MINIMALLY PLAUSIBLE BELEIVING IS IF THE POLE SOMEHOW MOVES THE WIRES OUTWARDS IN A LATERAL MOVEMENT AND NOT OA VERTICAL MOVEMENT BUT STILL THE LINES AND THE LIMBSWERE NEVER IN ANY WAY INTERFERRING WITH EACH OTHER. I CAN PROVIDE PICTURES TO PROVETHIS IF NEEDED. NOT TO MENTION THAT FROM THAT POLE TO THE NEXT THE LINES MOVE DIAGONALLY ACROSS THE STREET AWAY FROM THE TREES. IT JUST SO HAPPENS THAT THE POLE THAT WAS SUDDENLY REPLACED AND THE ONLY POLE AROUND THAT WAS REPLACED HAD THE TAG NUMBER THAT CORRESPONDED TO THE NUMBER ON THE PEICE OF PAPER I WAS GIVEN ON THE 6THOF APRIL. MR. BREWER HAS CHANGED HIS STORY FROM ONE THING TO THE NEXTAND DESTRYOED EVIDENCE THAT WOULD HAVE SURELY PROVEN HE WAS AND IS STILL WRONG ON THESE MATTERS AND HE HAD USED HIS POSITION TO ASSERT HIS POWER OF PRESIDENT OF CLARK RECC AGAINSTME CAUSING ME A VERY HUGE FINANCIAL BURDEN THAT I SIMPLY CAN NOIT BE RESPONSIBLE FORAMONGST THE OTHER DIEMNAS I HAVE AT THE PRESENT TIME. IT IS CAUSING ME A FINANCIAL CRISIS THAT IS CAUSING A VERY LARGE AND FINANCIAL BURDEN UPON ME AND WRONGFULLY SO.IT COSTS ME MORE THAN \$30 A DAY IN GAS TO POWER A GENERATOR SO THAT I CAN HAVE POWERFOR ONE REFRDIGERATOR, ONE LIGHT, AND ONE PC. THAT MONEY WAS MEANT FOR OTHER BILLS AND COULD HAVE AKLSO GONE TO HELP A LITTLE ON THE PAST DUE AMOUNT OWED TO CLARK RECC. IT HAS SO FAR TOTALLED OVER \$500 AND THE WEAR AND TEAR ON THE APPLIANCES HAS MOST CERTAINLY SHORTENED THEIR LIFESPAN TO A HUGE DEGREE AS I AM SURE YOU ARE AWAREAPPLIANCES SUCH AS SENSITIVE ELECTRONICS AND APPLIANCES ARE NOT MREANT TO BE AND AREIRREVERSIBLY DAMAGED BY GENERATOR POWER AND IT'S FLUXUACTIONS. IT HAS ALREADY DESTROYED MY \$1,300 APC THAT I WAS USING AS

BACKUP POWER FOR MY SENSIVTIVE ELECTRONICS. THIS MATTER NEEDS TO BE ADDRESSED IMMEDIATLEY PLEASE AS MY DISABILITY CAN NOT AFFORD THE GAS ALONE FOR A GENERATOR FOR A MONT LET ALONE MY OTHRE BILLS SUCH AS MORTGAGE PAYMENT, INSURANCE, GROCERIES, WATER, ETC. ETC.

WHAT I ASK OF THE COMMISSION:

I ASK THAT THE COMMISSION HAVE MY ELECTRIC TURNED BACK ON, THAT THE MONEY I HAVE SPENT TOWARDS GAS BE REIMBURSED IMMEDIATELY. I ALSO ASK THAT THE COMMSSION LOOK INTO THE MONEY PAID FOR THE UTILITY LIGHT AND THAT ALSO BE REIMBURSED WHEN THE FACTS ARE LAID OUT AS THAT COULD GO TOWARDS ANY REMAINING LATE CHARGES OWED TO CLRAK RECC MINUS ANY RECONNECT, LATE FEES, OR DEPOSITS (THERE WOULD NOT BE ANY OF THESE HAD THE ENTIRE SITUATION BEEN HAMDLED APPROPRIATELY) SINCE MY ACCOUNT HAS NOW BEEN CLOSED BECAUSE OF ALL THIS. CLOSED ON THE VERY DAY I WAS INFORMED IT WAS TO BE CLOSED WITH NO PRIOR NOTICES AT ALL. I ALSO ASK THAT THE COMMSION HAVE CLARK RECC REPLACE MY APC THAT NO LONGER FUNCTIONS PROPERLY BECAUSE OF BEING USED ON GENERATOR POWER AND ANY OTHER APPLIANCES THAT MAY STOP WORKING, ONLY THE APC THUS FAR HAS BEEN AFFECTED, BEFORE THE POWER IS RESTORED. I ALSO ASK THAT THE COMMSSION LOOK INTO THE REASONS BEHIND MR. BREWER CHANGING OUT THE POLE, NOT PROVIDING REQUESTED DOCUMENTS, NOT TRYING TO WORK WITH ME ON A PAYMENT ARRANGMENT, AND THE CHANGING OF HIS STORY THROUGHOUT THIS ENTIRE ORDEAL AND AT A MINIMUM REPREMAND HIM, (GIVEN THE CIRCUMSTANCES I FEEL HE SHOULD BE FORCED TO RESIGN) FOR HIS ACTIONS AND HIS UNACCEPTABLE USE OF HIS POSITION AS PRESIDENT OF RECC. I TOO KNOW SEVERAL BOARD MEMBERS AND AM QUITE FAMILIAR WITH AN EX-PRESIDENT OF CLARK RECC BUT I HAVE NOT ONCE UNTIL NOW EVEN MENTIONED THIS OR THOUGHT ABOUT USING ANY INFLUENCE IN THIS MATTER AS I AM NOT WRONG IN THIS. I HAVE A RECORDED CALL OF MR. BREWER REPEATEDLY STATING IT WAS SHUT OFF BECAUSE I FAILED TO UPHOLD AN ARRANGEMENT. AN ARRANGMENT WE NEVER HAD AND HE ADMITS TO NOT HAVING ON THE VERY SAME PHONE CALL. I HAVE SUBMITTED THAT CALL ALREADY TO THE P.S.C. ONE LAST THING I WOULD ASK IS THAT MR. BREWER RECALL THE SUMMONS HE HAD ME SERVED WITH FORCING ME TO APPEAR IN COURT FOR HARRASSING COMMUNICATIONS. ACCORDING THE FCC IT IS ONLY CONSIDERED HARRASSMENT IF THERE IS NO VALID REASON TO CALL AND IN THIS SITUATION I FEEL I AM COMPLETELY JUSTIFIED IN CALLING AS I INTENDED TO MAKE AS MUCH RECORD OF THE EVENTS AS I COULD AND I STATED SO ON SEVERAL OCCASIONS DURING THOSE CALLS. IF THE COMMISSION REQUIRES IT, I CAN GET WRITTEN STAEMENTS FROM THE NEIGHBOR VALIDATING THE FACT THAT THERE HAS BEEN NO LIGHT ON AT THE TOP OF THE CUL-DE-SAC SINCE THEY MOVED IN WHICH WAS AFTER I HAD IT SHUT OFF. THEY MOVED IN IN THE FIRST PART OF 2017 AFTER COMPLETING THE BUILDING OF THE HOUSE.
