COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO JOYCE YVONNE EPPERSON

Joyce Yvonne Epperson, pursuant to 807 KAR 5:001, is to file with the Commission the following information. The information requested is due on November 17, 2021, in paper form clearly marked with Case No. 2021-00363 delivered to the Commission at 211 Sower Blvd., Frankfort, Kentucky 40602-0615.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Ms. Epperson shall make timely amendment to any prior response if she obtains information that indicates the response was incorrect when made or, though correct when

made, is now incorrect in any material respect. For any request to which Ms. Epperson fails or refuses to furnish all or part of the requested information, she shall provide a written explanation of the specific grounds for her failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Ms. Epperson shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide copies of any bills to Ms. Epperson from West Laurel Water Association, Inc. from October 2020 to present.
2. Provide copies of any documentation received from West Laurel Water Association, Inc. regarding termination of Ms. Epperson's service.
