ORDER

On July 10, 2025, Walker Ryan Judd filed a complaint alleging that Jackson Energy Cooperative Corporation changed its petition signature procedures for running for its Board of Directors to prevent his compliance with the signature requirements.¹ By Order issued August 28, 2025, the Commission determined that pursuant to 807 KAR 5:001, Section 20(4)(a), Mr. Judd had not established a *prima facie* case, but was entitled to an opportunity to amend his complaint within 20 days of service of the Order. Mr. Judd was served with a copy of the Order on September 15, 2025.² He did not file an amended complaint within 20 days of service.
