ORDER

On January 21, 2026, Kathleen Fletcher Collins (Complainant) filed a complaint alleging that Martin County Water District (Martin County District) refused to allow her to disconnect the water service to her residence. On May 6, 2026, the Commission ordered Martin County District to satisfy the matter complained of or file a written answer. On May 15, 2026, Martin County District filed a written answer.

After reviewing the record, the Commission, on its own motion, finds that a procedural schedule should be established for the orderly processing of this case. The procedural schedule is attached as an Appendix to this Order. The Commission also finds that a copy of this Order should be served by U.S. Postal Service, First-Class mail on Kathleen Fletcher Collins at 3320 Blacklog Road, Inez, Kentucky 41224.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed.

2. Martin County District and the Complainant shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests.

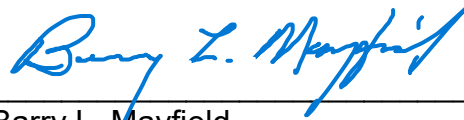
