07/29/08 Final Order Entered: 1) NKWD is granted a CPC&N to install AMR system. 2) NKWD shall obtain approval from PSC prior to performing any additional construction not expressly authorized. 3) Any deviation from construction approved shall be undertaken only with prior approval of Commission. 4) NKWD shall furnish documentation of total costs of project within 60 days of date construction is substantially completed. 5) Upon installation of proposed AMR system, NKWD shall physically inspect or examine meter pits & installations at least once annually. 6) Should NKWD issue any evidences of indebtedness whose proceeds will be used to finance purchase & installation of AMR system & KRS 278.300 requires prior Commission approval of such issuance, NKWD shall obtain such approval prior to issuance of those evidences of indebtedness. 7) In its financial & statistical report for calendar year 2008 & each following year, NKWD shall provide written report on status of installation and efforts to transition to monthly meter reading & billing. Report should include NKWD's most recent analyses on cost & benefits of monthly billing in light of present number of installed drive-by AMR meters.
