|          | (1) Adair Water is granted a Certificate of Public Convenience and Necessity for the proposed construction project.  |
|          | (2) Adair Water's proposed plan of financing with RD is accepted.  |
|          | (3) Adair Water is authorized to issue its Waterworks Revenue Bonds from the RD loan in the amount of \$1,100,000 at an interest rate not exceeding 2.75 percent per annum, maturing over 40 years.                      |
|          | (4) The proceeds from the loan agreement with RD shall be used only for the purposes specified in Adair Water's application.   |
|          | (5) Notwithstanding Ordering paragraph 4, if surplus funds remain after the construction has been completed, Adair Water may use such surplus to construct additional plant facility if RD approves of the use.          |
|          | (6) Adair Water shall file a copy of the "as-built" drawings and a certified statement that the construction has been completed in accordance with the contract plans within 60 days of completion.                      |
|          | (7) Adair Water shall monitor the adequacies of the expanded water distribution system after construction.   |
|          | (8) Adair Water shall notify the Commission one week prior to the actual start of construction and at the fifty percent completion point.  |
|          | (9) The rates set out in the Appendix are approved for service rendered on and after the date of this Order.   |
|          | (10) Within 30 days of the date of this Order, Adair Water shall file its revised tariffs.   |
|          | (11) Three years from the date of this Order, Adair Water shall file an income statement.  |
