NKWD shall notify the Commission seven days prior to start of construction and at 50 percent completion point. NKWD is authorized to assess each customer of Subdistrict H, a monthly surcharge

NKWD shall notify the Commission seven days prior to start of construction and at 50 percent completion point. NKWD is authorized to assess each customer of Subdistrict H, a monthly surcharge of \$30. NKWD shall cease collection of the surcharge when the collection of the debt incurred to construct the Subdistrict H facilities has been retired. NKWD shall identify the surcharge as a separate line item on its bills to Subdistrict H customers. On April 1, 2012, and each year thereafter so long as NKWD assesses the surcharge, NKWD will adjust the surcharge level to reflect the number of Subdistrict H customers as of December 31 of the preceding year. Beginning in 2012 and for each

calendar year thereafter in which the surcharge is effective NKWD shall submit a written report. Within

20 days of the date of this Order, NKWD shall revise its filed rate schedules.
