BREC shall inform the Commission if the designated materials become publicly available or no longer qualify for confidential treatment. 6. If a non-party to this proceeding requests to inspect the designated materials and the period during which the materials have been granted confidential treatment has not expired, BREC shall have 20 days from receipt of written notice of the request to demonstrate that the designated materials still fall within the exclusions from disclosure requirements established in KRS 61.878. If BREC is unable to make such demonstration, the designated materials shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection.

Big Rivers Electric Corporation ("Big Rivers") shall appear in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, on November 9, 2016, at 9:00a.m. , Eastern Standard Time, to submit itself to examination on the application of its Fuel Adjustment Clause ("FAC") from November 1, 2015, through April 30, 2016. Neither opening statements nor summaries of pre-filed testimony will be permitted. 2. Not less than seven days and no more than 21 days prior to the scheduled hearing, Big Rivers shall publish in a newspaper of general circulation in each area in which it serves notice of the purpose, time, place, and date of the scheduled hearing. In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov." 3. Big Rivers shall file with the Commission no later than November 7, 2016, proof of publication of its notice for the hearing. 4. The official record of the proceeding shall be by video only.
