The information requested in the Appendix to this Order is due no later than 14 days from the date of entry of this Order. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Responses shall include name of the witness responsible for responding to the questions related to the information provided, an original in

paper medium and an electronic version to the Commission.
