Beginning in the second fullbilling month following the date of this Order, KU shall decrease its jurisdictional environmental revenue requirement by \$541,726 for three months. 3. Beginning in the second full-billing month following the date of this Order, KU shall use a WACC of 7.13 percent, a tax gross-up factor of 0.75, an

ROE rate of 9.725 percent, and an overall

grossed-up return of 8.86 percent for its Pre-2020 Plans and a WACC of 6.85 percent, a tax gross-up factor of 0.75, an ROE rate of 9.200 percent, and an overall grossed-up return of 8.48 percent for its 2020 Plan in all future monthly environmental surcharge filings unless directed otherwise by the

Commission. 4. This case is closed and removed from the Commission's docket.
