modification is denied. 2. The current gas cost sharing calculation shall be modified as required herein, so that variances from 0 to 4.5 percent of Columbia Kentucky's Actual Gas Costs are shared 70 percent to ratepayers and 30 percent to shareholders, with sharing thereafter allocated 50/50 between Columbia Kentucky and its customers. 3. Columbia Kentucky's PBR mechanism, with the modification required herein, is extended through March 31, 2024. 4. Within 60 days after March 31, 2023, Columbia Kentucky shall file an evaluation report on the results of the PBR mechanism for the PBR years ending in 2021 through 2023. This report shall be considered in any proceeding established to continue, modify, or terminate the PBR mechanism. 5. Within 20 days of the date of this Order, Columbia Kentucky shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the PBR tariff revision approved herein and reflecting that they were approved pursuant to this Order. 6. All documents filed in the future pursuant to ordering paragraph 4 herein shall reference this case number and shall be retained in the post-case correspondence file, unless filed with a request to extend or modify the PBR mechanism. 7. This case

is closed and removed from the Commission's docket.
