BREC is granted a CPCN to construct and operate the 161 kV transmission line, the South Henderson Switching Station, and the Henderson Paper Mill Substation set forth in its application. 2. BREC shall follow the process set forth in this Order if constructability concerns require that the location of the proposed transmission line be moved more than 100 feet in any direction from the location as identified in the application. 3. BREC is granted authority to move the location of proposed transmission line up to 500 feet in either direction from the centerline as proposed in the application for the sole purpose of responding to a landowner request. 4. BREC shall notify the Commission of any move of the transmission line that is greater than 50 feet and made in response to a landowner request by filing a notice into the post-case correspondence file of this proceeding as set forth in this Order. 5. BREC's request for authority to move the location of the switching station and the substation from the proposed locations as long as the facilities are not moved onto the property of another property owner is granted. 6. BREC shall file a survey of the final location of the transmission facilities after any modifications are finalized as authorized by this Order and before construction begins. 7. BREC shall file as built drawings and maps within 60 days of the completion of the construction authorized by this Order.
