Hardin District #1's proposed plan of financing is approved. 3. Hardin District #1 shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 4. Notwithstanding ordering paragraph 3, if surplus funds remain after the approved

construction

has been completed, Hardin District #1 may use such surplus to construct additional plant facilities if RD approves of the use and the additional construction will not result in a change in Hardin District #1's

rate for service. Hardin District #1 shall provide written notice of this

additional construction in accordance with 807 KAR 5:069, section 4. 5. Hardin District #1 shall file with the Commission documentation of the total costs of this project, including the cost of construction and all other capitalized costs (e.g., engineering, legal, and administrative), within 60 days of the date that construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the

Commission.
