Bath District is granted a CPCN to rehabilitate the six water storage tanks, to rehabilitate the Midland Pump Station, and to replace the Ore Mines Pump Station as set forth in its application. 2. Bath District shall immediately notify the Commission upon knowledge of any material changes to the projects, including but not limited to increase in cost and any significant delays. 3. Any material deviation from the construction approved by this Order shall be undertaken only with prior approval of the Commission. 4. Bath District shall file with the Commission documentation of the total costs of the projects, including the cost of construction and all other capitalized costs (e.g., engineering, legal, administrative, etc.) within 60 days of the date that construction authorized under this CPCN is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 5. Bath District shall file a copy of the as-built drawings and a certified statement that the

construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certificated herein. 6. Bath District is authorized to issue the evidences of debt requested subject to the conditions discussed herein.
