Ordering paragraph 14 of Order, is stricken and replaced with: As ordered in Case No. 2021-00444, Allen District shall apply for a general rate adjustment pursuant to 807 KAR 5:001, Section 16, or an application for an alternative rate adjustment pursuant to 807 KAR 5:076, based on a 2024 test year, or in the alternative, file a formal motion with a detailed analysis of its rates and revenues explaining why no modifications are necessary, on or before January 28, 2025.

11/08/24 Final Order Entered: 1. Allen District is granted a CPCN for the proposed project as submitted. 2. Allen District's proposed plan of financing as submitted is approved. 3. Allen District is authorized to execute the loan agreement with KIA and, under the terms of that Agreement, to borrow from KIA an amount not to exceed \$700,000, said amount to be repaid over 20 years with interest rate of 1.25 percent per annum. 4. The proceeds from the loan agreement shall be used only for the purposes specified in Allen District's application. 5. Allen District shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 6. Allen District shall file with the Commission documentation of the total costs of this project, including the cost of construction and all other capitalized costs (e.g., engineering, legal, and administrative), within 60 days of the date that construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 7. Allen District shall file a copy of the as-built drawings and a certified statement from the engineer that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of substantial completion of the construction certified herein.
