09/03/25 Final Order Entered: 1. BREC's application and revised TIER credit of \$7.0 million are approved. 2. BREC's request to apply the \$4.2 million current regulatory balance above the TIER Credit Regulatory Liability minimum balance is approved. 3. The Commission finds that BREC's proposal to recalculate the amortization expense for its SLM Regulatory Assets, including the Green Station Regulatory Asset, using balances as of December 31, 2024, and to continue this methodology in future years is approved. 4. The revised TIER Credit mechanism is approved. BREC shall continue to file an annual application to allow for discovery and potential modifications to the TIER Credit mechanism, as necessary. The existing filing process shall remain in place. 5. BREC shall continue to file annually, by February 28th of each year, an application to adjust its MRSM rates pursuant to ordering paragraph 10 of the June 25, 2020 Order in Case No. 2020-00064. The filing shall contain the information set forth in the June 25, 2020 Order in Case No. 2020-00064, and ordering paragraph 6 of the August 17, 2020 Order in Case No. 2019-00365. 6.
