Sentra shall file its next quarterly GCR rate report for rates effective May 1, 2026, with at least 30 days' notice prior to the beginning of each calendar quarter as established in its Purchased Gas Cost Adjustment Clause Tariff. 2. Sentra shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports. 3. Sentra shall file its responses to the Request for Information included as the Appendix, when it files its next GCR report for rates effective for May 1, 2026. 4. Any under- or over-recoveries of gas costs that would have otherwise been reconciled in this case, shall be reconciled in the GCR rate report filed by Sentra for rates effective May 1, 2026. 5. Sentra shall maintain its records in such a manner as will allow Sentra, and the Commission, to determine the amounts of gas costs recovered through Sentra's GCR rate mechanism. 6. The Commission reserves its right to initiate an investigation to determine whether Sentra's GCR mechanism is accurately collecting the system's gas procurement related costs, should the Commission deem it necessary. 7. This case is closed and removed from the Commission's docket.

If Sentra files notice of its intention to place the proposed GCR rates into effect after the end of the suspension period, Sentra shall maintain its records in such manner as will allow it, the Commission, or any customer to determine the amounts to be refunded and to whom in the event a refund is ordered upon final resolution of this matter. 4. Sentra shall respond to Commission Staff's request for information as provided in the Appendix attached to this Order. 5. Sentra shall respond to any additional requests for information propounded by Commission Staff, as provided in those requests.
