Adair District is granted a Certificate of Public Convenience and Necessity to proceed with the proposed construction.</li> <li>2. Adair District shall notify the Commission prior to performing any additional construction not authorized by this Order.</li> <li>3. Any deviation from the construction approved shall be undertaken only with the approval of the Commission.</li> <li>4. Adair District shall furnish documentation of the total costs of this construction including the cost of construction and all other capitalized costs within 60 days of the date that construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission.</li> <li>5. Adair District shall file with the Commission a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of substantial completion of the construction certificated herein.</li> <li>6. Adair District shall require the construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky registration in civil, electrical, or mechanical engineering to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project.</li> </ol>
