(2) No later than March 10, 2015, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party of record shall file with the Commission: a. Its written comments on and any objections to the findings and recommendations contained in the Commission Staff Report; b. Any additional evidence for the Commission's consideration; and, c. Written notice as to whether this matter may be submitted for decision based upon the existing record without hearing. (3) If Commission Staff finds that Reid Village's financial condition supports a higher rate than Reid Village proposes or the assessment of an additional rate or charge not proposed in Reid Village's application, Reid Village, in its response to the Commission Staff Report, shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge. (4) If Commission Staff recommends changes in the manner in which Reid Village accounts for the depreciation of Reid Village's assets, Reid Village, in its response Staff Report, shall state its position

on whether Commission should require Reid Village to implement proposed change for accounting
