2. LG&E is granted retroactively an extension until June 30, 2018, of the reassessment interval required by 49 C.F.R. Section 192.939 for covered segments of the Calvary Pipeline, 3, Within thirty days of date of this Order, LG&E shall certify to Commission that its written transmission integrity management program provides that: a. Any request for a waiver of a transmission pipeline integrity reassessment interval shall be filed at least 180 days before the end of the required reassessment interval, unless local product supply issues make the period impractical, in which case the request shall be filed as soon as the need for the waiver becomes known. b. Any extension of the deadline to complete a transmission pipeline integrity reassessment is limited to an additional six months. 4. Pursuant to 49 U.S.C. Section 60118(d), Commission shall give notice to PHMSA of its waiver of reassessment interval required by 49 C.F.R.
