Atmos is authorized to implement a \$3,000,000,000 universal shelf registration for equity and debt financing, subject to the provisions and terms contained within its application, superseding the previous universal shelf authority granted in Case No. 2015-00346. 2. The proceeds from the transaction authorized herein shall be used only for the lawful purposes set out in the application. 3. Atmos shall, within ten days after each issuance of the securities referenced herein, file with the Commission a statement setting forth the date or dates of issuance, the price paid, the interest rate if any, the purchasers, and all fees and expenses, including underwriting discounts or commission or other compensation, involved in the issuance. In addition, if debt securities were issued, Atmos shall include an explanation as to how the interest rate alternative chosen represents the most reasonable interest rate available at the time of issuance, as well as copies of any executed interest rate management agreements. 4. Any documents filed pursuant to ordering paragraph 3 of this Order shall reference the number of this case and shall be retained in the post-case correspondence file. 5. The remaining universal shelf registration authority granted to Atmos in Case No. 2015-00346 shall be terminated with the registration of the universal shelf registration that has been approved in this case. 6. This case is closed and removed from the Commission's Docket. |
