Kentucky Power's proposed base fuel cost of \$.02851 per kWh is approved. 3. Kentucky Power shall increase its base energy rates by \$.00126 per kWh to reflect the reestablishment of base fuel costs. 4. The rates in the Appendix to this Order are approved effective with service rendered on and after February 1, 2020. The rates in the Appendix to this Order are designed to reflect the increase of \$.00126 per kWh to base energy rates, which is the differential between the old base fuel cost of \$.02725 per kWh and the new base fuel cost of \$.02851 per kWh. 5. Beginning with the expense month for February 2020, Kentucky Power shall use a FAC rate based upon a base fuel cost of \$.02851 per kWh. 6.
