more series in the aggregate amount of \$550,000,000 for the purpose of refinancing the \$125,000,000 Term Loan maturing June 17, 2023; the refinancing of a \$150,000,000 Term Loan due December 31,

2023; the refinancing a \$125,000,000 Term Loan due December 31, 2023; and to issue other securities in the amount of \$125,000,000 for its general corporate purposes. 2. Kentucky Power shall agree only to such terms and conditions for the secured private placement debt that are consistent with those terms and conditions set out in Kentucky Power's application. 3. Kentucky Power is authorized to enter into Treasury Hedge Agreements and Interest Rate Management Agreements as described in

the application.

4. Kentucky Power is authorized to determine the subsequent date of whether there will be more than one series, and the maturity of each series of Notes. 5. The proceeds from the transaction authorized shall be used for the lawful purpose set out in the application. 6. Kentucky Power shall file, within 30 days from the date of issuance, a statement setting forth the date or dates of issuance of the securities authorized, the date of maturity, price paid, proceeds of such issuances, the interest rate, costs or gains from the use of hedging agreements, and all fees and expenses, including underwriting

discounts, commissions, or other compensations involved in the issuance and distribution.
