Kentucky Power is granted a deviation from KRS 278.2207 for purchases of equipment from Grid Assurance upon Qualifying Events at Original Cost for five years from the date of service of this Order. 4. Kentucky Power shall provide final transfer, or if applicable, acquisition details, within 30 days of any Qualifying Event transaction occurring under the terms of the Grid Assurance Agreement and shall supplement such initial reporting with subsequent final documents. 5. Kentucky Power shall notify the Commission should there be any change in the Sparing Service to be provided by Grid Assurance or in the fee to be paid by Kentucky Power for that service. 6. Any documents filed pursuant to ordering paragraphs 4 and 5 of this Order shall reference the number of this case and shall be filed into the post-case correspondence file. 7. This Order in no way affects the Commission's jurisdiction over rates, services, or any

matters whatsoever subject to the Commission's jurisdiction that may come before it, nor shall anything herein be construed as acquiescence in any estimate of costs, or any valuation of property claimed or asserted.
