Within 20 days of the date of service of this Order, Nicholas District shall provide notice to its customers of the rates appearing in Appendix E by publishing a one- time notice of the rates in a newspaper of general circulation in its territory or placing an insert in bills rendered to its customers. 5. Nicholas District shall respond to requests for information propounded by Commission Staff as provided in those requests. 6. Nicholas District shall file any PWA application following its filing of tariff sheets as directed in this Order.
