Final Order Entered: Columbia/Adair District is granted a CPCN for the proposed projects, as submitted. 2. Columbia/Adair District's proposed plan of financing is approved. 3. Columbia/Adair District is authorized to enter into a loan in the amount of \$5,577,650 with KIA, maturing over a period of 20 years and with an interest rate not to exceed 1.25 percent with a principal forgiveness not to exceed \$3,629,468. 4. The proceeds of the loans shall be used only for the purposes specified in Columbia/Adair District's application. 5. Columbia/Adair District shall obtain approval from the Commission prior to performing any additional construction not expressly authorized by this Order. 6. Columbia/Adair District shall file with the Commission documentation of the total costs of this project, including the cost of construction and all other capitalized costs (e.g., engineering, legal, and administrative), within 60 days of the date that construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission. 7. Columbia/Adair District shall immediately notify the Commission upon knowledge of any material changes to the projects, including but not limited to an increase in cost and any significant delays.
