This report shall be considered in a proceeding which will be established to continue, modify or terminate the PBR mechanism. LG&amp;E shall also file with that report any testimony and supporting documentation that it would propose to be considered, in addition to the record of this case, to assist the Commission in determining whether gas cost PBR should be continued for Kentucky LDCs, or whether it should be modified or terminated.</li> </ul>
