TO ALL JURISDICTIONAL UTILITIES AND INTERESTED PARTIES

The Public Service Commission has formed stakeholder advisory groups to assist in the review and revision of its rules of procedure (807 KAR 5:001) and its regulation on tariffs (807 KAR 5:011). A list of members of each advisory group is attached. The Public Service Commission announced its intention to form such groups on October 14, 2011 and selected the members of each advisory group based upon responses to that announcement.

Each advisory group will shortly begin meeting with Commission Staff to discuss public comments on the existing regulations and to identify possible revisions. As Commission Staff develops possible amendments to each regulation, it will submit these amendments to the appropriate advisory group for discussion. After each regulation has been fully reviewed, the Public Service Commission will release a proposed revised version to the public for comment. Only after considering these public comments will the Public Service Commission make any submission to the Legislative Research Commission to promulgate a revised administrative regulation.

The Public Service Commission encourages all interested persons to continue to submit suggestions and comments regarding the regulations under review.
