CASE NO. 4378-Y

ORDER

On March 25, 1965, the Commission issued its Final Order in Case No. 4378 approving certain rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On October 17, 1980, the Applicant, Elzie Neeley Gas Company, Inc., notified the Commission that its wholesale cost of gas would be increased by one of its suppliers, Columbia Gas of Kentucky, Inc., effective November 1, 1980, and submitted with its notice certain information in compliance with this Commission's Order of March 25, 1965. The Notice set out certain revisions in rates which the Applicant proposed to place in effect, said rates being designed to increase the cost of natural gas of its supplier.

The amount of the increased cost of gas to the Applicant will be \$1,145.78 on an annual basis.

After reviewing this evidence of record and being fully advised, the Commission is of the opinion and finds:

(1) That the Applicant's supplier has filed increasedrates and said rates will become effective on and after November1, 1980.

(2) That the Applicant's notice of October 17, 1980, failed to provide the twenty (20) days notice as required by Statute and, therefore, the rates should become effective for service rendered on and after November 6, 1980.

(3) That the Applicant's adjustment in rates under the Purchased Gas Adjustment approved by the Commission in its Order in Case No. 4378 dated March 25, 1965, is fair, just and reasonable and in the public interest and should be allowed to be effective with gas supplied on and after November 6, 1980. IT IS THEREFORE ORDERED that the rates including the proposed Purchased Gas Adjustment be and the same are hereby approved to be effective with gas supplied on and after November 6, 1980, as set out in Appendix "A" attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of the future application of the Purchased Gas Adjustment Clause of the Appliant, the Base Rate for purchased gas shall be:

Commodity

\$3.178 per MCF

Columbia Gas of Kentucky, Inc.

IT IS FURTHER ORDERED that the information furnished this Commission by the Applicant on October 17, 1980, constitutes full compliance with the Commission's Order and any other information ordinarily required to be filed under the Commission's Regulations is hereby waived.

IT IS FURTHER ORDERED that within thirty (30) days after the date of this Order, the Applicant shall file with this Commission its revised tariff sheets setting out the rates approved herein.
