#### ORDER

On December 20, 1972, the Commission issued its Final Order in Case No. 5743, approving certain rates and providing under ceratin conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On August 20, 1980, the Applicant, Phelps Gas Company, Inc., notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas of Kentucky, effective August 5, 1980, and submitted with its notice certain information in compliance with this Commission's Order of December 20, 1972. The notice set out certain revisions in rates which the Applicant proposed to place in effect with gas supplied on and after August 5, 1980, said rates being designed to decrease the cost of natural gas of its supplier in the amount of \$2,413.46.


After reviewing this evidence of record and being advised, the Commission is of the opinion and finds:

(1) That the Applicant's supplier has filed decreased rates and said rates became effective on and after August 5, 1980, and resulted in an annual decrease of \$2,413.46.

(2) That the adjusted rates under the Purchased Gas Adjustment Clause approved by the Commission in its Order in Case No. 5743, dated December 20, 1972, as set out herein are fair, just and reasonable and in the public interest and should be allowed to be effective with gas supplied on and after August 5, 1980.

IT IS THEREFORE ORDERED that the rates including the proposed Purchased Gas Adjustment be and the same are hereby approved to be effective with gas supplied on and after August 5, 1980, as set out in Appendix "A" attached hereto and made a part hereof.
