ORDER

On December 26, 1979, Green River Electric Corporation (here-inafter Green River) filed an application for rehearing in this matter, requesting that the Commission amend its Order of December 1, 1979, to reflect any adjustment of the rates of Big Rivers Electric Corporation as a result of its rehearing in Case No. 7380.

In the original order in this matter the Commission found that Green River was entitled to recover the increased wholesale power costs granted in Case No. 7380 of \$7,806,236. Therefore, the Commission is of the opinion and finds that Green River should be allowed to recover the additional revenue granted Big Rivers in Case No. 7380 on rehearing which will result in an overall increase in power costs of approximately \$10,155,896.

IT IS THEREFORE ORDERED, that the rates set out in Appendix "A" to the Order dated December 1, 1979, are hereby set aside.

IT IS FURTHER ORDERED, that the rates set out in Appendix "A" attached hereto are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED, that Green River Electric Corporation shall file within twenty (20) days from the date of this Order, its tariff sheets setting out the rates and charges approved herein.

FUEL ADJUSTMENT CLAUSE FOR SPECIAL CONTRACTS

The energy charge in any month under the above schedule shall be increased or decreased by a fuel adjustment charge according to the following formula:

$$\frac{\mathbf{F}^{1}}{\mathbf{P}}$$
 = Rate applicable to each KWH sold

Where \mathbf{F}^1 is the aggregate charge from the Corporation's wholesale power supplier for fuel adjustment, purchased power adjustment, in the Corporation's wholesale power contract; where P is the total KWH's purchased. The rate resulting from this formula shall be applied to each kilowatt hour sold in the current month.

^{*}The monthly kilowatt hour usage shall be subject to plus or minus an adjustment per KWH determined in accordance with the "Fuel Adjustment Clause."
