The Commission having considered the motions to intervene made by the Attorney General and Mrs. Loretta F. Bennett, Hartford, Kentucky and being sufficiently advised hereby sustains said motions.

The applicant having pre-filed its testimony in this case and the parties having had adequate opportunity to review said testimony:

IT IS THEREFORE ORDERED That all requests to applicant from intervenors for additional information be completed by October 15, 1980, and that applicant respond to said request by October 30, 1980.

IT IS FURTHER ORDERED That intervenors shall make any further information request in such manner that applicant could reasonably respond to said requests by October 30, 1980, and applicant shall so respond.

IT IS FURTHER ORDERED That intervenors who desire to present evidence in this matter shall pre-file their testimony no later than November 10, 1980.

IT IS FURTHER ORDERED That applicant shall complete its request for information, if any, to intervenors no later than November 21, 1980.

IT IS FURTHER ORDERED That a hearing be set at the Commission's offices beginning at 10:30 a.m. on November 20, 1980, for the purpose of intervenor's cross examining applicant as to its pre-filed testimony.


IT IS FURTHER ORDERED That intervenors shall respond to applicant's request for information so that said response will be in applicant's hands no later than December 5, 1980.

IT IS FURTHER ORDERED That intervenors shall submit their witnesses for cross examination by applicant beginning at 2:00 p.m. at the Commission's offices on December 11, 1980.

IT IS FURTHER ORDERED That intervenors shall submit briefs no later than December 20, 1980, and that applicant's brief be submitted no later than January 5, 1981.
