O R D E R

On January 7, 1981, Kentucky-American Water Company (Company), by counsel, filed its Motion requesting authority to file the testimony of the Company's President, J. James Barr, on February 2, 1981 rather than on or before January 22, 1981 as set forth in the Commission's Order entered December 23, 1980.

The Commission, having considered the Motion and being advised, hereby ORDERS that said Motion be and it hereby is sustained.

IT IS FURTHER ORDERED That all Requests for Information to Kentucky-American Water Company shall be submitted on or before February 13, 1981, with copies to parties of record.

IT IS FURTHER ORDERED That Kentucky-American Water Company shall file Responses to the Requests for Information on or before February 27, 1981, with copies to parties of record.

IT IS FURTHER ORDERED That Intervenors shall file their testimony in verified prepared form on or before March 20, 1981, with copies to parties of record.

IT IS FURTHER ORDERED That all Requests for Information to Intervenors shall be submitted on or before March 30, 1981, with copies to parties of record.

IT IS FURTHER ORDERED That Intervenors shall file Responses to the Requests for Information on or before April 10, 1981, with copies to parties of record.

IT IS FURTHER ORDERED That a hearing be and it hereby is scheduled on April 21, 1981, at 9:00 a.m., Eastern Standard Time, in the Commission's offices at Frankfort, Kentucky, for the purpose of cross examination of witnesses of Kentucky-American Water Company.

IT IS FURTHER ORDERED That a hearing be and it hereby is scheduled on April 23, 1981, at 9:00 a.m., Eastern Standard Time, in the Commission's offices at Frankfort, Kentucky, for the purpose of cross examination of witnesses of Intervenors and the presentation of rebuttal testimony, if any, by Kentucky-American Water Company.

IT IS FURTHER ORDERED That Kentucky-American Water Company and Intervenors shall file briefs simultaneously on May 15, 1981.
