O R D E R

On March 25, 1965, the Commission issued its Order in Case No. 4378 approving certain rates and providing, under certain conditions, for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On November 30, 1981, Elzie Neeley Gas Company, Inc., ("Elzie Neeley") notified the Commission that its wholesale cost of gas was decreased by its supplier Columbia Gas of Kentucky, Inc. ("Columbia"). Elzie Neeley has proposed to place their revised rates into effect on and after December 20, 1981.

Elzie Neeley filed with its notice of November 30, 1981, a method to refund to its customers \$96.53 by credit on its billings. Elzie Neeley proposes to refund this amount to its customers over a 2-month period in accordance with the refund provisions of Elzie Neeley's purchased gas adjustment clause beginning on and after December 20, 1981, said adjustment being designed to pass on to its customers a reduction in the amount of \$0.016 per Mcf during December 1980 and adjusting this factor during January

1982 to insure that the total amount will be refunded to its customers.

After reviewing this evidence of record and being advised, the Commission is of the opinion and finds that:

(1) Elzie Neeley has applied an adjustment for line loss in the amount of 5 percent. In all the previous purchased gas adjustment cases related to Case No. 4378, Elzie Neeley failed to adjust for any line loss and passed on to its customers the increase cost of wholesale gas based on the increase per Mcf to them from their supplier. The 5 percent line loss adjustment is a proper adjustment and should be included in this purchased gas adjustment.

By allowing Elzie Neeley the adjustment for line loss the results will be an increase to the consumers in the amount of approximately \$650 annually.

(2) Elzie Neeley's supplier has filed revised rates and said rates will become effective on and after December 20, 1981.

(3) Elzie Neeley has \$96.53 to be refunded to its customers.

(4) The said refund should remain in effect for 2 months or until such time as the full amount, plus interest, has been returned to its customers.

(5) Elzie Neeley should refund the amount reported in its application, plus interest, at a rate equal to the average of the

"Three Month Commercial Paper Rate" for the immediately preceding 12-month period less 1/2 of 1 percent to cover the cost of re-funding. These monthly rates are reported in both the Federal Reserve Bulletin and the Federal Reserve Statistical Release.

IT IS THEREFORE ORDERED that the purchased gas adjustment sought by Elzie Neeley be and the same is hereby approved.

IT IS FURTHER ORDERED that the rates contained in Appendix A be and are hereby approved, effective for gas supplied on and after December 20, 1981.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Elzie Neeley, the base rate for purchased gas shall be:

Commodity

Columbia Gas of Kentucky, Inc.           \$4.127 per Mcf

IT IS FURTHER ORDERED that Elzie Neeley apply a refund factor in the amount of \$0.016 per Mcf during December 1981 and adjust said factor during January 1982 to assure the full amount plus interest, will be returned to its customers. The refund factor will terminate at such period of time that the refundable amount equals the refund herein reported, plus interest.

IT IS FURTHER ORDERED that the information furnished this Commission by Elzie Neeley in this case constitutes full compliance with the Commission's Order in Case No. 4378, and any other information ordinarily required to be filed under the Commission's Regulations is hereby waived.

IT IS FURTHER ORDERED that within 30 days after the date of this Order, Elzie Neeley shall file with this Commission its revised tariff sheets setting out the rates approved herein.
