O R D E R

On March 25, 1965, the Commission issued its Order in Case No. 4378 approving certain rates and providing, under certain conditions, for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On December 22, 1981, Elzie Neeley Gas Company, Inc., ("Elzie Neeley") notified the Commission that its wholesale cost of gas would be increased by one of its suppliers, Columbia Gas of Kentucky, Inc., ("Columbia") effective January 1, 1982, and submitted with its notice certain information in compliance with this Commission's Order of March 25, 1965. The notice set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to increase the cost of natural gas of its supplier.

The amount of the increased cost of gas to Elzie Neeley will be \$1,787 on an annual basis.

After reviewing this evidence of record and being fully advised, the Commission is of the opinion and finds that:

(1) Elzie Neeley's supplier has filed increased rates and said rates will become effective on and after January 1, 1982.

(2) Elzie Neeley's notice of December 22, 1981, failed to provide the 20 days notice as required by Statute and, therefore, the rates should become effective for service rendered on and after January 11, 1982.

(3) Elzie Neeley's adjustment in rates under the purchased gas adjustment approved by the Commission in its Order in Case No. 4378 dated March 25, 1965, is fair, just and reasonable and in the public interest and should be allowed to be effective with gas supplied on and after January 11, 1982.

IT IS THEREFORE ORDERED that the rates including the proposed purchased gas adjustment be and are hereby approved to be effective with gas supplied on and after January 11, 1982, as set out in Appendix A attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Elzie Neeley, the base rate for purchased gas shall be:

IT IS FURTHER ORDERED that the information furnished this Commission by Elzie Neeley on December 22, 1981, constitutes full compliance with the Commission's Order and any other information ordinarily required to be filed under the Commission's Regulations is hereby waived.

IT IS FURTHER ORDERED that within 30 days after the date of this Order, Elzie Neeley shall file with this Commission its revised tariff sheets setting out the rates approved herein.
