O R D E R

On March 25, 1965, the Commission issued its Order in Case No. 4378 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On September 24, 1982, Elzie Neeley Gas Company ("Elzie Neeley") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas of Kentucky, Inc., ("Columbia") effective October 1, 1982, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the evidence of record and being advised, the Commission is of the opinion and finds that:

1. Elzie Neeley's notice of September 24, 1982, set out certain revisions in rates which Elzie Neeley proposed to place in effect, said rates being designed to pass on the wholesale decrease in price from its supplier in the amount of \$1,490 or 9.3 cents per Mcf.

2. Due to the retroactive nature of Columbia's decrease, Elzie Neeley should report to the Commission any excess revenues collected during the period of September 1, 1982, through September 30, 1982, along with a plan to refund any excess collections to its customers.

3. Elzie Neeley's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 4378 dated March 25, 1965, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after October 1, 1982.

IT IS THEREFORE ORDERED that the rates contained in Appendix A be and they are approved effective for gas supplied on and after October 1, 1982.

IT IS FURTHER ORDERED that Elzie Neeley shall report to the Commission any excess revenues collected during the period of September 1, 1982, through September 30, 1982, along with a plan to refund any excess collections.

IT IS FURTHER ORDERED that within 30 days from the date the decreased cost of gas becomes effective, Elzie Neeley shall file with the Commission its revised tariff sheets setting out the rates approved herein.

The following rates are prescribed for the customers in the area served by Elzie Neeley Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect prior to the date of this Order.

RATES: Monthly

First 3,000 Cubic Feet

\$18.90 Minimum Bill

All Over 3,000 Cubic Feet

6.30 per Mcf
