ORDER

On March 24, 1979, the Commission issued its Order in Case No. 5988 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On November 5, 1982, Pendleton County Water District, Gas Division ("Pendleton") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas Transmission Corporation ("Transmission") effective October 1, 1982, and submitted with its notice certain information in compliance with its purchased gas adjustment clause on file with this Commission.

After reviewing the evidence of record and being advised, the Commission is of the opinion and finds that:

(1) Pendleton's notice of November 5, 1982, set out certain revisions in rates which Pendleton proposed to place into effect, said rates being designed to pass on the wholesale

decrease in cost from its supplier in the amount of \$5,191 or \$0.0179 per Mcf.

- (2) Due to the retroactive nature of Transmission's decrease, Pendleton should report to the Commission any excess revenues collected during the period of October 1, 1982, and the date the proposed rates are implemented, along with a plan to refund any excess collections to its customers.
- (3) Pendleton's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 5988 dated March 24, 1979, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after October 1, 1982.

IT IS THEREFORE ORDERED that the rates contained in Appendix A be and they hereby are approved for gas supplied on and after October 1, 1982.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased gas adjustment clause of Pendleton, the base rate for purchased gas shall be:

*Includes Transportation Charge of \$0.3377

IT IS FURTHER ORDERED that Pendleton shall report to the Commission any excess revenues collected during the period of October 1, 1982, and the date the proposed rates are implemented, along with a plan to refund any excess collections.

IT IS FURTHER ORDERED that within 30 days after the date the decreased cost of wholesale gas becomes effective, Pendleton shall file with this Commission its revised tariff sheets setting out the rates approved herein.
