ORDER

On May 11, 1982, North Nelson Water District ("North Nelson") filed its application seeking authority to adjust its rates in accordance with 807 KAR 5:067, Purchased Water Adjustment Clause. On February 12, 1982, North Nelson's supplier, City of Bardstown, notified North Nelson of an increase in the wholesale cost of water from \$.385 to \$.60 per 1,000 gallons.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

- (1) The City of Bardstown increased the wholesale cost of water to \$.60 per 1,000 gallons to be effective with the May 1, 1982, billing.
- (2) The financial exhibits filed by North Nelson indicate that it cannot absorb an increase of this magnitude in the cost of wholesale water.
- (3) The calculation for the purchased water adjustment made by North Nelson is correct and shows an increase of \$.23 per 1,000 gallons. However, North Nelson is requesting to pass on to its customers only \$.15 per 1,000 gallons of the increase at this time.

The requested increase is reasonable and should be approved.

(4) The base rate for future application of the purchased water adjustment clause should be:

\$.60 per 1,000 gallons

(5) The rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment sought by North Nelson and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of North Nelson, the base rate for purchased water shall be:

IT IS FURTHER ORDERED that within 30 days of the date of this Order, North Nelson shall file with the Commission its revised tariff sheets setting out the rates approved herein.
