# ORDER

On December 20, 1978, the Commission issued its order in Case No. 7156 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On April 6, 1982, Martin Gas Company, Inc., ("Martin") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas of Kentucky, Inc. ("Columbia") effective April 19, 1982, and submitted with its notice certain information in compliance with this Commission's order of December 20, 1978. The notice set out certain revisions in rates which Martin proposed to place in effect, said rates being designed to decrease the cost of the natural gas of its supplier in the amount of \$1,154.

After reviewing this evidence of record and being advised, the Commission is of the opinion and finds that:

(1) Martin's supplier, has filed for decreased rates and said rates will become effective on and after April 19, 1982.

(2) Martin's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its order in Case No. 7156 dated December 20, 1978, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after April 19, 1982.

IT IS THEREFORE ORDERED that said purchased gas adjustment sought by Martin and adjusted as aforesaid be and is hereby approved to be effective with gas supplied on and after April 19, 1982, as in Appendix A attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased gas adjustment clause of Martin the base rate for purchased gas shall be:

#### Commodity

Columbia Gas of Kentucky, Inc.\$ 4.871 per McfSoutheastern Gas Company.140

IT IS FURTHER ORDERED that the information furnished this Commission by Martin on April 6, 1982, constitutes full compliance with the Commission's order in Case No. 7156 and any other information ordinarily required to be filed under the Commission's regulations is hereby waived.

IT IS FURTHER ORDERED that within 30 days after the date the decreased cost of wholesale gas becomes effective, Martin shall file with this Commission its revised tariff sheets setting out the rates approved herein.
