O R D E R

On April 21, 1982, Christian County Water District ("Christian County") filed its application with the Public Service Commission seeking authority to adjust its rates for service in accordance with 807 KAR 5:067, Purchased Water Adjustment Clause. Christian County's supplier, Barkley Lake Water District, notified Christian County of an increase in the wholesale cost of water from \$.86 to \$.93 per 1,000 gallons pursuant to an Order of the Public Service Commission in Case No. 8264, Application of Barkley Lake Water District, dated March 10, 1982.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) Christian County's supplier, Barkley Lake Water District, increased the wholesale cost of water to \$.93 per 1,000 gallons effective April 20, 1982.

(2) The financial exhibits filed by Christian County indicate that it cannot absorb the increased cost of wholesale water.

(3) The calculation for the purchased water adjustment made by Christian County in the amount of \$.03 per 1,000 gallons is correct and the purchased water adjustment should be approved.

(4) The base rate for purchased water for the future application of the purchased water adjustment clause should be:

<u>Supplier</u>	<u>Rate</u>
Barkley Lake Water District	\$.93 per 1,000 gallons

(5) The rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment sought by Christian County and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of Christian County, the base rate for purchased water shall be:

<u>Supplier</u>	<u>Rate</u>
Barkley Lake Water District	\$.93 per 1,000 gallons

IT IS FURTHER ORDERED that within 30 days after the date of this Order, Christian County shall file with the Commission its revised tariff sheets setting out the rates and the purchased water adjustment clause approved herein.
