O R D E R

IT IS ORDERED That McKinney Water Association shall file an original and eight copies of the following information with the Commission by August 16, 1982:

1. Submit a statement from supplier that reconciles with the application with respect to the supplier's rate and the effective date of that rate (contained within the application is a statement by the applicant that the new rate from the supplier will be \$1.0782 per 1,000 gallons and the effective date of the new rate will be 8/1/82. However, in a letter from the supplier filed as Exhibit I the new rate is listed as \$1.0825 per 1,000 gallons and the effective date will be 5/6/82. Also, there is no signature on the letter from the supplier).

IT IS FURTHER ORDERED That in the event the above information is not timely filed, the Commission may dismiss the case without prejudice absent a Motion for Extension of Time for good cause.

AMENDED ORDER
