O R D E R

On July 30, 1982, McKinney Water Association ("McKinney") filed its application seeking authority to adjust its rates in accordance with 807 KAR 5:067, Purchased Water Adjustment Clause. McKinney's supplier, City of Stanford, notified McKinney of an increase in the wholesale cost of water from \$.8625 to \$1.0782 per 1,000 gallons effective August 1, 1982.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) McKinney's supplier, City of Stanford, increased the wholesale cost of water to \$1.0782 per 1,000 gallons, effective August 1, 1982.

(2) The financial exhibits filed by McKinney indicate that it cannot absorb the increased cost of wholesale water.

(3) The calculation for the purchased water adjustment in the amount of \$.12 per 1,000 gallons made by McKinney is correct and should be approved.

(4) The base rates for further application of the purchased water adjustment clause should be:

(5) The rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment in the amount of \$.12 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of McKinney, the base rates for purchased water shall be:
