O R D E R

On May 4, 1982, Tri-Village Water District ("Tri-Village") filed its application with the Public Service Commission seeking approval of a purchased water adjustment clause and authority to adjust its rates for service in accordance with that clause. Effective January 1, 1982, Tri-Village's supplier, City of Owenton ("City"), increased Tri-Village's rates from \$.66 to \$.79 per 1,000 gallons.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) The purchased water adjustment clause sought by Tri-Village is in compliance with 807 KAR 5:067, Purchased Water Adjustment Clause, is in the best interest of the public and should be approved.

(2) The City increased the wholesale cost of water to \$.79 per 1,000 gallons effective January 1, 1982.

(3) The financial exhibits filed by Tri-Village indicate that it cannot absorb the increased cost of wholesale water.

(4) The calculation for the purchased water adjustment made by Tri-Village in the amount of \$.232 per 1,000 gallons is correct and the purchased water adjustment should be approved.

(5) The base rate for purchased water for the future application of the purchased water adjustment clause should be:

<u>Supplier</u>	<u>Rate</u>
City of Owenton	\$.79 per 1,000 gallons

(6) The rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment clause filed by Tri-Village is hereby approved effective on and after the date of this Order.

IT IS FURTHER ORDERED that the purchased water adjustment sought by Tri-Village and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of Tri-Village, the base rate for purchased water shall be:

<u>Supplier</u>	<u>Rate</u>
City of Owenton	\$.79 per 1,000 gallons

IT IS FURTHER ORDERED that within 30 days after the date of this Order, Tri-Village shall file with the Commission its revised tariff sheets setting out the rates and the purchased water adjustment clause approved herein.
