O R D E R

On October 13, 1980, the Commission issued its Order in Case No. 7800 approving certain adjustments in rates and providing under certain conditions for the further adjustments of such rates when the wholesale cost of gas is increased or decreased.

On March 24, 1982, Mt. Olivet Natural Gas Company, Inc., ("Mt. Olivet") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas Transmission Corporation ("Transmission") effective March 1, 1982, and submitted with its notice certain information in compliance with this Commission's Order of October 13, 1980. The notice set out certain revisions in rates which Mt. Olivet proposed to place in effect, said rates being designed to decrease the cost of natural gas of its supplier in the amount of \$1,080.

After reviewing this evidence of record and being advised, the Commission is of the opinion and finds that:

(1) Mt. Olivet's supplier, Transmission, has filed with the Federal Energy Regulatory Commission ("FERC") for decreased rates to become effective March 1, 1982.

(2) This decrease reflects Transmission's rates as filed with FERC on March 16, 1982, to be effective March 1, 1982.

(3) Mt. Olivet's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 7800 dated October 13, 1981, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after the date the decreased cost of wholesale gas becomes effective.

IT IS THEREFORE ORDERED that said purchased gas adjustment sought by Mt. Olivet and adjusted as aforesaid be and is hereby approved to be effective with gas supplied on and after the date the decreased cost of wholesale gas becomes effective, as in Appendix A attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Mt. Olivet the base rate for purchased gas shall be:



IT IS FURTHER ORDERED that the information furnished this Commission by Mt. Olivet on March 24, 1982, constitutes full compliance with this Commission's Order in Case No. 7800 and any other information ordinarily required to be filed under the Commission's regulations is hereby waived.

IT IS FURTHER ORDERED that within 30 days after the date the decreased cost of wholesale gas becomes effective, Mt. Olivet shall file with this Commission its revised tariff sheets setting out the rates approved herein.

The following rates are prescribed for the customers in the area served by Mt. Olivet Natural Gas Company, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the date of this Order.

RATES: Monthly

First	1,000 cu. ft. or less	\$7.07 (Minimum Bill)
Next	4,000 cu. ft. per 1,000 cu. ft.	5.3269
Next	5,000 cu. ft. per 1,000 cu. ft.	5.1269
Next	10,000 cu. ft. per 1,000 cu. ft.	4.9769
Over	20,000 cu. ft. per 1,000 cu. ft.	4.7769
