O R D E R

On April 23, 1981, the Commission issued its Order in Case No. 7897 approving certain adjustments in rates and providing, under certain conditions, for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On March 26, 1982, Auxier Road Gas Company, Inc., ("Auxier") notified the Commission that its wholesale cost of gas would be decreased by its supplier, Columbia Gas of Kentucky, Inc., ("Columbia") effective April 19, 1982, and submitted with its notice certain information in compliance with this Commission's Order of April 23, 1981. The notice set out certain revisions in rates which Auxier proposed to place in effect, said rates being designed to decrease the cost of gas to its customers in the amount of \$1,430.

After reviewing this evidence of record and being advised, the Commission is of the opinion and finds that:

(1) Auxier's supplier has filed decreased rates and said rates will become effective on and after April 19, 1982.

(2) Auxier's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 7897 dated April 23, 1981, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after April 19, 1982.

IT IS THEREFORE ORDERED that said purchased gas adjustment sought by Auxier and adjusted as aforesaid be and is hereby approved to be effective with gas supplied on and after April 19, 1982, as in Appendix A attached hereto and made a part hereof.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Auxier the base rate for purchased gas shall be:

Columbia Gas of Kentucky, Inc.	\$4.871 per Mcf

IT IS FURTHER ORDERED that the information furnished this Commission by Auxier on March 26, 1982, constitutes full compliance with the Commission's Order in Case No. 7897 and any other information ordinarily required to be filed under the Commission's regulations is hereby waived.

IT IS FURTHER ORDERED that within 30 days after the date the decreased cost of wholesale gas becomes effective, Auxier shall file with this Commission its revised tariff sheets setting out the rates approved herein.
