O R D E R

On April 23, 1981, the Commission issued its Order in Case No. 7897 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates when the wholesale cost of gas is increased or decreased.

On August 9, 1982, Auxier Road Gas Company, Inc. ("Auxier") notified the Commission that its wholesale cost of gas would be increased by its supplier, Columbia Gas of Kentucky, Inc. ("Columbia") effective September 1, 1982, and submitted with its notice certain information in compliance with this Commission's Order of April 23, 1981. The notice set out certain revisions in rates which Auxier proposed to place in effect, said rates being designed to recover the increased cost of gas from its supplier in the amount of \$66,316.

After reviewing this evidence of record and being advised, the Commission is of the opinion and finds that:

(1) Auxier's supplier, Columbia, has filed for increased rates and Auxier's notice of August 9, 1982, reflected the increased rates.

(2) Auxier's adjustment in rates under the purchased gas adjustment clause approved by the Commission in its Order in Case No. 7897 dated April 23, 1981, is fair, just and reasonable, in the public interest and should be effective with gas supplied on and after September 1, 1982, subject to refund.

IT IS THEREFORE ORDERED that the rates contained in Appendix A be and they are approved, effective for gas supplied on and after September 1, 1982, subject to refund.

IT IS FURTHER ORDERED that for the purpose of the future application of the purchased gas adjustment clause of Auxier the base rate for purchased gas shall be:

Commodity

Columbia Gas of Kentucky, Inc.

\$ 5.613 per Mcf

IT IS FURTHER ORDERED that the information furnished this Commission by Auxier on August 9, 1982, constitutes full compliance with the Commission's Order in Case No. 7897.

IT IS FURTHER ORDERED that within 30 days after the date the increased cost of wholesale gas becomes effective, Auxier shall file with this Commission its revised tariff sheets setting out the rates approved herein.
