#### ORDER

On October 14, 1982, Western Bracken Water District ("Western Bracken") filed an application with the Public Service Commission ("Commission") seeking approval of a purchased water adjustment clause and authority to adjust its rates in accordance with that clause.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

 The purchased water adjustment clause sought by Western Bracken is in compliance with 807 KAR 5:067, Purchased Water Adjustment Clause, is in the best interest of the public, and should be approved.

2. Western Bracken's supplier, Bracken County Water District No. 1 ("Bracken County"), increased the cost of wholesale water pursuant to an Order of the Commission in Case No. 8323, Application of Bracken County Water District No. 1, Brooksville, Kentucky, dated June 9, 1982. The increased rates were placed into effect on July 1, 1982. 3. The calculations made by Western Bracken are correct and show a total allowable increase in purchased water costs of \$6,733.68, resulting in a purchased water adjustment to its rates of \$.31 per 1,000 gallons.

4. The financial exhibits filed by Western Bracken indicate that it cannot absorb the increased cost of wholesale water.

5. The purchased water adjustment sought by Western Bracken and the rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment clause filed by Western Bracken is hereby approved effective on and after the date of this Order.

IT IS FURTHER ORDERED that the purchased water adjustment in the amount of \$.31 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of Western Bracken, the base rate for purchased water shall be:
