O R D E R

On September 17, 1982, Pendleton County Water District ("Pendleton") filed an application with the Public Service Commission ("Commission") seeking authority to adjust its rates in accordance with 807 KAR 5:067, Purchased Water Adjustment Clause.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

1. Pendleton County Water District consists of two divisions, Division I serving customers in northern Pendleton County and southern Campbell County, and Division II serving customers in the area of Falmouth, Kentucky. The divisions do not connect in any way and water is purchased from different suppliers for each division.

2. Pendleton's supplier for Division I, Campbell County Water District, increased the wholesale cost of water from \$.68 to \$.73 per 1,000 gallons effective July 1, 1982.

3. The calculations made by Pendleton are correct and show a total allowable increase in purchased water costs of

\$2,275.11, resulting in a purchased water adjustment to its rates of \$.05 per 1,000 gallons.

4. The financial exhibits filed by Pendleton indicate that it cannot absorb the increased cost of wholesale water.

5. The purchased water adjustment sought by Pendleton and the rates in Appendix A are fair, just and reasonable and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment in the amount of \$.05 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for service rendered to customers served by Division I on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of Pendleton, the base rate for purchased water shall be:

<u>Supplier</u>	<u>Rate</u>
City of Falmouth	\$.75 per 1,000 gallons
Campbell County Water District	.73 per 1,000 gallons

IT IS FURTHER ORDERED that within 30 days of the date of this Order, Pendleton shall file with the Commission its revised tariff sheets setting out the rates approved herein.
