O R D E R

On November 20, 1981, the Commission entered an Order approving an increase in rates for Jackson Purchase Electric Cooperative Corporation ("Jackson Purchase"). The rates and charges in Appendix A to that Order were placed into effect subject to refund pending the final decision of the Federal Energy Regulatory Commission (FERC) regarding Kentucky Utilities Company's ("Kentucky Utilities") application for wholesale power increase, docket number ER81-341. Jackson Purchase was ordered to maintain its records so that, should a refund be required in the final decision by FERC, the refund to the customers of Jackson Purchase could be quickly determined.

On July 15, 1982, FERC approved wholesale settlement rates effective November 21, 1981, in docket number ER81-341. These rates result in a lower wholesale power bill for Jackson Purchase and a refund to Jackson Purchase from Kentucky Utilities of charges

in excess of these rates since November 21, 1981. On August 9, 1982, Jackson Purchase submitted proposed tariffs and supporting work papers reflecting the reduced wholesale power bill.

The Commission, after review of the evidence and being advised, is of the opinion and finds that:

1. The wholesale settlement rates approved by FERC will result in a decrease of power cost to Jackson Purchase and a refund of charges in excess of the settlement rates from Kentucky Utilities.

2. The revised rates and charges in Appendix A are designed to reflect the reduced power cost from Kentucky Utilities allowed by FERC and will not result in any additional net margin to Jackson Purchase.

3. Jackson Purchase should refund to its customers an amount equal to the refund it receives from Kentucky Utilities plus interest at a rate equal to the average of the "3-Month Commercial Paper Rate" for the immediately preceding 12-month period less 1/2 of 1 percent to cover the costs of refunding. These monthly rates are reported in both the Federal Reserve Bulletin and the Federal Reserve Statistical Release.

IT IS THEREFORE ORDERED that the rates and charges in Appendix A shall be placed into effect for service rendered on and after November 21, 1981.

IT IS FURTHER ORDERED that Jackson Purchase shall file within 30 days from the date of this Order a plan for refunding excess charges to its customers.

IT IS FURTHER ORDERED that Jackson Purchase shall file within 30 days from the date of this Order its revised tariff sheets setting out the rates approved herein.
