O R D E R

On August 30, 1982, Simpson County Water District ("Simpson County") filed its application with the Public Service Commission ("Commission") seeking approval of a purchased water adjustment clause and authority to adjust its rates for service in accordance with that clause.

The Commission, having reviewed the evidence of record and being advised, is of the opinion and finds that:

(1) The purchased water adjustment clause sought by Simpson County is in compliance with 807 KAR 5:067, Purchased Water Adjustment Clause, is in the best interest of the Public and Simpson County, and should be approved.

(2) On August 20, 1982, Simpson County's supplier, Franklin Municipal Water System ("Franklin"), notified Simpson County of an increase in the wholesale cost of water to \$.54 per 1,000 gallons to be effective October 1, 1982.

(3) The financial exhibits filed by Simpson County indicate that it cannot absorb an increase of this magnitude in the cost of wholesale water.

(4) The calculation for the purchased water adjustment made by Simpson County in the amount of \$.27 per 1,000 gallons is correct and should be approved.

(5) The rates proposed by Simpson County are incorrect and, insofar as they differ from the rates in Appendix A, should be denied.

(6) The rates in Appendix A are the fair, just and reasonable rates to be charged by Simpson County and should be approved.

IT IS THEREFORE ORDERED that the purchased water adjustment clause filed by Simpson County is hereby approved effective on and after the date of this Order.

IT IS FURTHER ORDERED that the rates proposed by Simpson County be and they hereby are denied.

IT IS FURTHER ORDERED that the purchased water adjustment in the amount of \$.27 per 1,000 gallons and the rates in Appendix A be and they hereby are approved for service rendered on and after the date of this Order.

IT IS FURTHER ORDERED that for the purpose of future application of the purchased water adjustment clause of Simpson County, the base rate for purchased water shall be:

Franklin Municipal Water System	\$.54 per 1,000 gallons

IT IS FURTHER ORDERED that within 30 days of the date of this Order, Simpson County shall file with the Commission its revised tariff sheets setting out the rates and purchased water adjustment clause approved herein.

The following rates are prescribed for the customers of Simpson County Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the date of this Order.
